III. AIR QUALITY AWARDS

ACTION: <u>It is requested that the Environmental Assistance and Protection</u> <u>Board make the final determination on which sources will receive Calendar</u> <u>Year 2013 Air Quality Awards</u>.

The Air Quality Awards Program recognizes industrial and institutional sources in Forsyth County for their compliance with air quality standards.

Each year, the Environmental Assistance and Protection Board members review the compliance histories of the permitted sources, determine which sources have met their responsibilities in controlling air emissions, and determine the air quality award recipients.

IV. SPECIAL AIR QUALITY AWARDS and SPECIAL ENVIRONMENTAL AWARDS

ACTION: <u>It is requested that the Environmental Assistance and Protection</u> <u>Board make a final decision on whether these facilities are winners of the</u> <u>Special Environmental Award.</u>

The Environmental Assistance and Protection Board may recognize companies and other organizations making exceptional efforts in reducing pollution. The Special Air Quality Award is presented to those companies/organizations that have reduced their air pollution beyond regulatory requirements and the Special Environmental Award reflects efforts made by companies/organizations to control pollution in any environmental media. Applications for the Special Environmental Awards have been received for *Winston-Salem/Forsyth County Schools – Carver High School, Winston-Salem/Forsyth County Schools – Clemmons Middle School, Winston-Salem/Forsyth County Schools Maintenance Division,* and *R. J. Reynolds Tobacco Co.* No applications were received for the Special Air Quality Award.

VI. PUBLIC HEARING ON THE REVISIONS TO FORSYTH COUNTY CODE AND AIR QUALITY TECHNICAL CODE

ACTION: <u>The Board is requested to consider comments presented at the public hearing and to make recommendations to the Director on the adoption of the proposed rule changes.</u>

Revisions to the Forsyth County Air Quality Technical Code have been proposed to incorporate changes adopted by the Environmental Management Commission. The proposed changes include revisions to the VOC RACT rules, 3D-0902, Applicability, 3D-0903 Recordkeeping: reporting: monitoring, 3D-0909 Compliance schedules for sources in new nonattainment areas, 3D-0935 Factory surface coating of flat wood paneling, 3D-0951 RACT for sources of volatile organic compounds, 3D-0961 Offset lithographic printing and letterpress printing, 3D-0962 Industrial cleaning solvents and revisions to the Toxic Air Pollutant Program, rules 3D-1104 Toxic air pollutant guidelines, 3Q-0102 Activities exempted from permit requirements, 3Q-0701 Applicability, 3Q-0702 Exemptions, 3Q-0703 Definitions, 3Q-0704 New facilities, 3Q-0705 Existing facilities and sic calls, 3Q-0706 Modifications, 3Q-0709 Demonstrations, and 3Q-0711 Emission rates requiring a permit. In addition, rule 3Q-0306 is being revised to modify the public notice requirements for permits containing limits to avoid the applicability of Title V permitting requirements. All other changes to the code are administrative corrections.
