GRANT CONTRACT

The grant to your organization from The Winston-Salem Foundation is for the purpose stated below. The grant is made subject to your acceptance of the terms described herein.

All grants are made in accordance with current applicable laws and the Internal Revenue Code, as amended.

1. **EXPENDITURE OF GRANT FUNDS:** Grant funds provided may be spent only for the purpose stated above, which is approved by The Winston-Salem Foundation Committee. The funded project and its budget may be changed only with the Foundation's prior approval.
 - (a) Funds will be disbursed to the grantee upon the Foundation's receipt of this signed agreement; and, if indicated, the satisfactory compliance with any special conditions.
 - (b) Any special conditions which apply to the grant should be met promptly. Adequate evidence of compliance with the conditions will be required before the Foundation releases funds.
 - (c) Expenses may not be charged against the grant prior to or after the date of the grant period without prior approval of the Foundation.
 - (d) The grantee is responsible for grant funds received and for maintaining adequate supporting records consistent with generally accepted accounting practices.
 - (e) Equipment or property purchased with grant funds shall be the property of the grantee organization unless the purpose of the organization changes or it should go out of existence. In either case, the equipment or property reverts to the Foundation.

2. **REVERSION OF GRANT FUNDS:** The grantee will return to the Foundation any funds not spent by the close of the grant period.

Also, if the Foundation determines that the grantee has breached this agreement, the grant will be canceled and all funds will be promptly returned to the Foundation.
