## ONE-STOP EARLY VOTING

## **PLACEMENT**

30 days before one-stop early voting starts (G.S. 163-227.2).

## REMOVAL

10 days after one-stop early-voting ends (G.S. 136-32). 30 days after the election, any person may remove and dispose of signs without penalty.

## **ELECTION DAY**

#### **PRIVATE PROPERTIES**

The owner must give permission for political signs to be posted - house, business, and religious institution fronting (G.S. 136-32 (d)).

#### **MUNICIPALITIES**

#### **CITY OF WINSTON-SALEM**

The placement of political signs is permitted as covered in G.S. 136-32.

## **PLACEMENT**

36 hours before the polls open on election day (G.S. 163-129 (d)).

30 days before one-stop early voting starts (G.S. 163-227.2).

Private properties: The owner must give permission for political signs to be posted - house, business, and religious institution fronting (G.S. 136-32 (d)).

\* Signs should be placed between two utility poles, behind or between fire hydrants, behind or between utility meters, or at the back of the sidewalk. In the absence of the indicators listed, signs should be placed six feet behind the curb or pavement edge.

## **REMOVAL**

36 hours after the polls close on election day (G.S. 163-129 (d)).

10 days after one-stop early-voting ends (G.S. 136-32). 30 days after the election, any person may remove and dispose of signs without penalty.

# WHEN CAN POLITICAL SIGNS BE PLACED? WHEN SHOULD IT BE REMOVED?

#### **TOWN OF LEWISVILLE**

The placement of political signs is permitted as covered in Lewisville's Town Code Chapter 38-1 F 6.

#### **VILLAGE OF CLEMMONS**

The placement of political signs is permitted as covered in G.S. 136-32.

#### **TOWN OF KERNERSVILLE**

The placement of political signs is permitted as covered in G.S. 136-32.

## **PLACEMENT**

30 days before one-stop early voting starts (G.S. 163-227.2).

- \* Political signs are prohibited in the rightsof-way of locally maintained roads.
- \* Signs not allowed on utility poles.

- \* In the Department of Transportation maintained roads, signs can't exceed 864 sq. inches.
